Context

Several studies suggest that financing urban infrastructure and services will double or triple in the coming decades. However, from a macroeconomic point of view, a growing gap between funding needs and priorities of investors is observed. This gap is particularly important in the financing process of urban infrastructures.

Despite the favorable conditions for long-term investments (low rates, abundant funds) and the increasing recognition of the role of cities in the development, large institutional investors do not prioritize urban investment, and public funding has decreased significantly in the last years.

To find new macroeconomic solutions and institutions it is essential to unlock the channeling of public and private savings into urban development if we are to achieve the SDGs and realize the New Urban Agenda.

Guiding questions

- How can cities better mobilize the local wealth produced within their territory in order to finance the city by the city?
- How can the global savings be channeled toward the local level to leverage investments? What financial mechanisms do we have to develop to respond to the urgency?
- What support can international organizations bring during the transition phase to a coherent, adjusted system of local finance that meets the needs?
